### **2. European Championship of Magic 2014**

We are proud to inform you, that the second European Championship of Magic will be held on a cruise ship. It will be organised by the Fédération Française des Artistes Prestidigitateurs FFAP.

The categories will be for stage "Manipulation, General Magic, Stage Illusions, Mental Magic, Comedy Magic" and for Close Up "Card Magic, Micro Magic, Parlour Magic".

All 1<sup>st</sup> and 2<sup>nd</sup> prize winners will have a non transferable guaranteed participation in the WCM2015. They don't need the written consent of the President of their society for the WCM anymore.

**A 1<sup>st</sup> or 2<sup>nd</sup> prize in the ECM is a guarantee of an entry into the FISM World Championship in Rimini in 2015.**

No competition fee shall be charged. A competitor will only have to pay the regular convention registration fee.
