FISM ECM SAINT-VINCENT 2024



The FISM European Championship of Magic FISM ECM Saint-Vincent (23/26 May 2024) is close and we must take into account these very important points:

- Sign up now and you will have many advantages. Take a look here: ECM FISM ITALY 2024 - FISM
- We remind all European Presidents that the deadline to submit their list of contestants (with the signed application form and necessary endorsements as specified in the FISM ECM competition rules) is 15th March 2024.
- We also remind all presidents who sign endorsements for contestants of their responsibility to ensure that the contestant in question has the

appropriate FISM level to face the competition. We remind you that according to the Art 1 competition rules, contestants who are disqualified or whose final score is below the FISM level, their presidents may be sanctioned without being able to sign guarantees again within a period of three years.

 Presidents whose association is not up to date with payments to the FISM (international and European) cannot endorse any contestant.

VOTING RESULTS – FISM ECM CONTEST RULES

Regarding the voting online of the FISM Europe GA (Lime survey kindly provided by FISM International) for changing the FISM ECM Contest Rules and Procedures <u>for having the 1st, 2nd, and 3rd places at ECM directly qualifies for the WCM</u>, as of the date of this meeting, we have **52 "yes" votes, 4 abstentions, and 3 "no" votes.**

We appreciate the high participation achieved and consider the requested change accepted and in force.

CAS (CONTEST ALLOCATION SYSTEM) FOR FISM ECM 2024

FISM ECM CAS, which entails **80 stage and 40 close-up slots** (total slots agreed with the ECM 2024 organizer). The FISM Europe Board unanimously approved this proposal.
